IN 2023, THE MUSEUM COLLECTION CONSISTS OF 135 HISTORIC VEHICLES, WHICH INCLUDE EIGHT VEHICLES DESIGNATED AS NATIONAL TREASURES. THE COLLECTION ALSO INCLUDES MORE THAN 6,000 OBJECTS, 70 TONS OF STUDEBAKER CORPORATE ARCHIVAL MATERIAL, AND 150 HANDS-ON EDUCATIONAL OBJECTS.
